FIRST AID

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Confine pets during application to prevent them from believing they are being fed. Keep pets out of treated area when bait is present.

PERSONAL PROTECTIVE EQUIPMENT (PPE)

USE IN ACCORDANCE WITH PRECAUTIONARY STATEMENTS AND DIRECTIONS FOR USE.** OR-CAL Slug & Snail Bait is a soil surface treatment for control of snails and slugs in citrus groves, orchards, berry crops, vegetable crops and gardens, ornamental gardens, seed grasses, dichondra and turf grass lawns and in ornamental greenhouses. When applied as directed, OR-CAL Slug & Snail Bait will withstand rain and sprinkling and will offer protection to gardens and lawns for several weeks.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. USE PRECAUTIONS

Read entire label before using. Use only as a baiting treatment to be applied directly to the soil area beneath plants as listed on this label. **DO NOT** allow bait pellet to come in contact with parts of plant that may be used for food or feed purposes. The grower is responsible for residues on his crops. **NOTE: OR-CAL SLUG & SNAIL BAIT SHOULD NOT BE APPLIED TO DRY SOIL.** Applications should be made following irrigation for best results. Apply any time of the day, but evening applications are preferred. **DO NOT** re-water for 48-hours after application.

APPLICATION INFORMATION:

For control of Snails and Slugs in the following areas, use 1 lb. to treat 1,100 to 1,500 sq. ft. of soil surface which is equivalent to 30 to 40 lbs. pellets per acre. For smaller areas, use one level teaspoon per square yard. Apply when first plant damage appears or is anticipated and repeat as needed for control.

FRUIT TREE CROPS: Apples, Apricots, Avocados, Cherries, Peaches, Pears, Citrus (Oranges, Lemons, Grapefruit, etc.)—Broadcast liberally under trees, around irrigation pipes, farm buildings and any other place where snails and slugs may congregate.

BERRY CROPS: Blackberries, Boysenberries, Loganberries, Raspberries, Strawberries. Apply only to soil surface.

VEGETABLE CROPS AND GARDENS SUCH AS: Artichoke, Asparagus, Beans, Beets, Blackeyed Peas, Broccoli, Brussels Sprouts, Cabbage, Cantaloupes, Cucumbers, Eggplant, Endive, Garlic, Ginseng, Horseradish, Kale, Kohlrabi, Leeks, Lettuce, Melons, Mustard Greens, Okra, Onions, Parsnips, Peas, Peppers, Pimientos, Potatoes, Pumpkins, Radishes, Rhubarb, Rutabagas, Salsify, Shallots, Spinach, Squash, Sweet Potatoes, Swiss Chard, Tomatoes, Turnips, Watermelons. Apply only to soil surface.

ORNAMENTAL PLANTS—ORNAMENTAL GARDENS, PLANTED BORDERS AND GROUND COVERS SUCH AS: Azaleas, Begonias, Camellias, Chrysanthemums, Daffodils, Daisies, Geraniums, Honeysuckle, Hydrangeas, Ice Plant, Impatiens, Iris, Marigolds, Pansies, Petunias, Rhododendrons, Rose, Sweet Peas, Snapdragons, Spathiphyllum, Tulip. Broadcast or sprinkle this product evenly over the infested areas and along edges of flower beds adjacent to border or ground cover plants. Also apply on ground at base of fences and walls in shady, protected locations. This product may be injurious to Daylilies and Clematis. Do not use on these plants.

DICHONDRA AND/OR TURF GRASS LAWNS: Broadcast this product directly and evenly.

ORNAMENTAL GREENHOUSES: Broadcast this product liberally around greenhouse, under benches in greenhouse and around plants; any place where snails and slugs might congregate. Do not apply directly to plants unless prior experience has shown the plant to be tolerant to this product. Most plants are tolerant to OR-CAL Slug & Snail Bait, however some slight tip burning has been noticed on extremely tender orchids. This product may be injurious to Daylilies and Clematis. Do not use on these plants. **NOTE:** OR-CAL Slug & Snail Bait has been proven to have a reasonable residual control, however, for heavily infested greenhouses a second application is recommended 7 to 10 days following the first application to bring the house under control.

SEED GRASSES: Broadcast this product directly and evenly.

NON-AGRICULTURAL REQUIREMENTS

The requirements in this box apply to uses of the product that are NOT within the scope of the Worker Protection Standard, for agricultural pesticides 40 CFR Part 170. The WPS applies only when this product is used to produce agricultural plants on farms, forests, nurseries, or greenhouses.
